8. New Business

Discuss raising the banquet tickets for members to \$20 and guests to \$30. With prices going up for everything, the league is subsidizing the banquet more and more each year. This year is \$11.00 per ticket for members, minimal, \$1.00 for guests. But the point is we shouldn't have to subsidize guests. Now this is fine for this year as we had some extra money from last year. But next year will be another story.

Discussion on Pot Luck, not accepted as too many have allergies. Motion to increase ticket prices made by Kiana and seconded by Gary - Passed

A couple of things came up when Michaela was verifying the scoresheets.

Players borrowed from other teams not always noted. When you borrow a player, please note that they are borrowed, which team they play on.

When doing up your scoresheets, please use the name of the player as registered. Several times nicknames were used and they didn't match any players registered on the team. Pretty hard to verify high scores, 180's, etc when you can't find the right person to award.

And finally, please write so it is readable. Again, pretty hard to verify if you can't read the name.

Discussion on the best way to do this, it was decided that when borrowing a player it would be noted on the sheet with what team they play on, for Michaela to pick up when doing reviews of sheets, and also that the players team captain should be aware to follow up.

Propose change to the community letter with the following addition:

"Inter-Community Dart League will not be responsible for any damages to venues. Responsibility for repaid and/or payment of damages will fall on the person(s) causing said damages."
